

Application for Keeping Pet(s)

I hereby undertake to:

1. Veterinarian's Certificate must be provided that the Authorized Pet(s) is in good health, has had the necessary inoculations and booster shots, is spayed or neutered, and declawed in the appropriate cases. The Certificate must be updated annually. The Certificate must be presented prior to the Authorized Pet(s) coming onto the premises.
 - Dogs must have valid vaccination against canine distemper, canine hepatitis and canine parvoviral infection.
 - Cats must have valid vaccination against cat flu (feline calicivirus and feline viral rhinotracheitis) and cat enteritis (i.e. feline panleukopenia/feline parvovirus)
2. A Veterinarian's Certificate must be submitted prior to admission of the Authorized Pet(s) certifying that the Authorized Pet(s) has received a flea treatment within seven (7) days prior to admission. The Management reserves the right to require the treatment within seven (7) days prior to admission. The Management reserves the right to require the treatment more frequently should problems arise
3. Certificate indicating proper licensing by Department of Veterinary Services (DVS) Malaysia must be provided prior to bringing the Authorized Pet(s) onto the premises. The Certificate must be updated annually.
4. Agrees to comply with all Health and Safety Codes and all other applicable governmental laws and regulations relating to pets.
5. Maximum pets allowed: 2 pets per apartment
6. Size for Dog Breeds allowed: (Weight: up to 15kg, Height: up to 25cm).
7. Pet Fee: RM90nett/night.
8. In the event if the Authorized Pet(s) defecate within the apartment, an amount of RM100nett will be imposed for additional cleaning.
9. Take all necessary steps to ensure, to the satisfaction of the Management, that the Authorized Pet(s) will not be a source of annoyance, noise, nuisance and/or danger to the other occupier(s) of neighbouring premises or along common property.
10. Should there be any complaints of disturbance or nuisance caused by excessive barking/meowing from the pet(s), the occupier/you will be required to remove the pet(s) immediately from the suite(s).
11. The occupier/you shall allow our representative(s) to enter into the above suite(s) at any time during your stay to conduct an inspection thereof to ensure that the suite(s) is kept in a livable and sanitary condition, failing which the occupier/you shall be liable to pay rectification costs for any damage to the suite(s), furniture or fittings within fourteen (14) days of written notification of the same.

12. The Authorized Pet(s) must be kept in the suite(s) at all times or carried in a carrier or stroller or leash when in the common areas or hallways of the building.
13. The Authorized Pet(s) is not allowed at our outdoor infinity pool, Fitness Center and meeting room.
14. The Authorized Pet(s) must be on leash and a muzzle must be put on when Housekeeping is cleaning the suite(s).
15. Take all necessary steps to ensure, to the satisfaction of the Management, that the Authorized Pet(s) will does/do not cause any damage to the property of the occupier(s) of neighbouring premises or to the common property.
16. Ensure that the Authorized Pet(s) will not defecate on the neighbouring premises or at the common property, and be responsible for removing all such defecation; and
17. Be responsible and bear all liabilities for all interference with peaceful enjoyment, damage to the properties and/or personal injuries caused by the actions of the Authorized Pet(s), and to indemnify and holds Dao by Dorsett Puteri Cove harmless for all or any liability damages, losses, costs, and expenses incurred by the Management as a result of the actions of the Authorized Pet(s).

I understand that the Management has the right to review the consent to allow me to keep the Authorized Pet(s) at Dao by Dorsett Puteri Cove and that the consent is revocable at the Management's absolute sole discretion. I understand that the Management's decision to revoke is final and conclusive and that the Management is not obliged to provide any reasons for the revocation of its consent.

Upon revocation of the Management's consent, I undertake that I shall immediately remove the Authorized Pet(s) from my apartment and/or common property.
